Vyjádření vedoucího diplomové práce/oponenta diplomové práce*:

This much longer diploma work is excellent in general with only some minor errors and a lack of systematic application to the theory of post-colonialism presented which is only briefly referred to in the work. Otherwise, there is shown a clear understanding demonstrated in the interpretation of the stories and a nuanced presentation of the language usage by Junot Díaz, i.e., his use of triple code-switching within the stories. Much of this code switching is correctly identified by Kuřátková with the Hispanic cultural tradition of machismo and the unadulterated effort to conceal true inner feelings and emotions, particularly of the males in the stories, and not just the issue of the usage of Spanish versus English.

The family strains due to both machismo and the immigration experience is accurately presented, but here more could have been accomplished in the interpretation through an

application of the theory of post-colonialism. The description of the narrator's father "Rámon" deviating from the norms of Dominican behavior (his polygamy) is definitely the effect of post-colonialism, for example.

Kuřátková provides excellent evidence that the behavior of the mother "Virtudes" falls into the common lot of Hispanic women suffering under the cultural manifestations of machismo. Miss Kuřátková worked with difficult texts which have not been translated into Czech and had limited resources of secondary literature. She also read Díaz's Pulitzer Prize winning novel The Brief Wondrous Life of Oscar Wao and integrated aspects of that very demanding novel into her reading of these short stories. Her conclusion and bibliography, following format requirements, are complete and thorough.

- 3. In your interpretation you show some sympathy for Rámon at times when no other character in the stories does. What does the reader know that the narrator does not?
