Critical comments and overall contributions, total value of the thesis

The choice of the topic is the result of a deep reflection and it can be said that the presented thesis delivers a well-documented overview. It can be considered as well as a very good basis for further studies on more specialized sub subjects of the main topic.

The methodological framework is well explained.

The thesis can serve as a basis for other studies which focus on more specified research questions. The main results can be transferred even two other cross-border regions. Besides this, they indicate indirectly also the fields where politics has to change in order two strengthen cross-border regional cooperation.

The only points which in my opinion could have been better elaborated are the presentations of the historical background of the two regions. Besides this it could have been explained that the nine germanophone municipalities of Eastern Belgium where represented as a part of the Province de Liège even before the adhesion of the German Community of Belgium (cf. p. 59). Even today these municipalities are part of the Province de Liège, but at the same time of the German Community with its own institutions. Another inexactitude is the definition of te enlarged region in Western Germany (p. 71, note 93). It is not as stated a region around Düsseldorf, but consists of the districts of Neuss, Kleve and Viersen and the City of Mönchengladbach, thus exclusively district on the left side of the Rhine. But these are small details which doesn't reduce the quality of this excellent thesis.
