In this context, one can highlight the logical structure of the theoretical part, discussing important key notions such as teleworking, the concept of virtual teams and finally the forms and functions of virtual team collaboration in the first part. The theoretical background is then completed by a very profound discussion of media theories and decision-making theories, with a special focus on the interconnection with interculturality. Thus, the author provides all relevant information for better understanding her research results.

The selected qualitative oriented approach (semi-directive interviews) seems suitable in order to answer her research questions. Furthermore, the study is based on 8 interviews with project managers coming from different types of organizations, allowing the author to gain insight not only in one single domain. The handling of data is thoroughly carried out. Here, one wants to highlight the very accurate data interpretation, especially the author's efforts by establishing correlations between different categories of the content analysis.
