The thesis deviated from its original topics.

The objective of the thesis is "de comprendre ce qu'est une université responsable, comprendre le cadre institutionnel qui régit les universités et de quelle façon le

DD peut être intégré dans les EES". Research question is "de quelle manière le développement durable est-il intégré dans les universités françaises?"

Only one page of conclusions follows the data analysis. I miss any summary of the analysis, a discussion (even the author mentioned on page 71 the existence of a discussion) or some implications from it. The authors conclude several problems of implementing sustainable development to the universities. The conclusions are mostly general, predictable and bring no suggestions.

The student elaborated the thesis without further contacting his supervisor after initial intensive consultations.

Questions and topics for discussion before the commission

Using flights for travelling of teachers and researchers seem be a strongly perceived element of the sustainability violation. Do you see a solution in that area?

The author has found the progress as well as the legal situation different in different countries - can there be a common solution at least in a group of countries or even for example on the level of the European Union?
